While thanking your goodself for grant of provisional affiliation to this school upto 31-03-2020, as per your above cited letter, the point wise reply is given hereunder for your kind information:-

1. In this connection, your kind attention is drawn to Govt. Order. No. 808-Edu of 1994 dt. 21.04.1994 (Copy enclosed - Annexure-I) where under extension for recognition was granted in favour of SPM Saplings School, Jogi Gate Jammu upto Class 8th till ending March, 1996.

Further, Jammu & Kashmir State Board of School Education, Jammu extended the recognition / affiliation vide their letter no. F (Affi-Gen) of March 1996 dated 11-03-1996 (Copy enclosed - Annexure-II) in favour of SPM Saplings School Jogi Gate, Jammu (Name of the School changed to Delhi Public School Jammu during April,1999) upto classes X till ending March, 2000 i.e before expiry of period of recognition / affiliation of the school upto class 8th, ending March, 1996.

Thereafter, the school's nomenclature was changed from SPM Sapling School Jogi Gate, Jammu to Delhi Public School, Jogi Gate Jammu vide Jammu and Kashmir State Board of School Education No. F (Acad-Gen) B/JD/99 dated 15-04-1999 (Copy enclosed - Annexure-III) issued by the Joint Secretary, J&K Board of School Education (Exam/Admin) Jammu province, which may kindly be perused.

Management of Delhi Public School Jammu, approached Central Board of Secondary Education, New Delhi for grant of affiliation to Delhi Public school, Jammu with CBSE which was granted by them as SPM sapling school Jammu whose nomenclature was changed to Delhi Public School Jammu, stood recognized/ affiliated by J&K State Board Of School Education upto class X, ending march, 2000 (copy enclosed-Annexure-III). Accordingly, our school students appeared in Class X CBSE examination during the session 2001-02.

**In this connection, it is pertinent to mention that the said affiliation to this school continued upto 31-03-2019 provisionally with CBSE, New Delhi in phased manner which has also been extended now provisionally upto 31-03-2020 as per your letter referred to above.**

In view of the above, you are requested to kindly extend affiliation in favour of Delhi Public School, Jammu beyond 31.03.2020, as already requested, for which I shall be highly obliged.
